Registration Fee – \$75.00 per child - This fee is non-refundable and non-transferable.

- 2024 Registration Fee will be drafted at registration.
- Child Care fees are monthly and will be drafted on the first of each month.
 - August payment will draft on August 14, 2024.
 - Starting after August 14, your first payment will draft at time of registration.
- Payments are divided evenly over the school year, September through May
- August 2024 and June 2025 payment will be prorated.

* The following cover all school days, spring and winter break, school holidays and staff development days.

Kinder Program A – This program is for Early Start Kinder children only. The program will run M, T, Th, F from 11:30 am – 2:30 pm and on Wednesday's from 11:30 am - 12:45 pm. This coverage does not cover school minimum days or non-school days. This coverage will only be offered if space permits.

Kinder Program B – This program is for Late Start Kinder children only. The program will run M, T, Th, F from 12:30 – 2:30 pm and on Wednesday's from 11:30 am – 12:45 pm. This coverage does not cover school minimum days or non-school days. This coverage will only be offered if space permits.

Slip Schedule – This program is for sibling children that are in a Kinder or First Grade slip schedule and have a school age sibling at Alamo Elementary. This program covers your child M, T, Th, F, from 8:00 am – 8:40 or 9:00 am or 1:50 pm – 2:25 pm. This coverage does not cover Wednesday's, school minimum days or non-school days. This coverage will only be offered if space permits.

TK AM - This program for TK children only. This program covers your child M, T, Th, F, from 9:00 am – 11:30 am. This coverage does not cover Wednesday's, school minimum days or non-school days. This coverage will only be offered if space permits.

Drop-in – Up to 4 hours \$61, anything over 4 hours \$98. The yearly registration fee is required for drop-in. Payments are due same day as drop-in occurs. Credit card or EFT draft payments are accepted for drop-in fees. Drop-in care is meant for limited use and is not intended to be used regularly. Drop-in care requires a 48 hour notice and is only available as enrollment allows. On non-school days, priority is given to regular attendees.

We charge the same for subsidized children as for non-subsidized children. Prices subject to change based on school schedules with a 30 day written notice.

The following days our sites will be closed:

New Year's Day, Martin Luther King Day, President's Day, Memorial Day, Labor Day, Veteran's Day, Thanksgiving Day, Day After Thanksgiving, Christmas Eve, Christmas Day, New Year's Eve. Plus 2 staff training days – dates TBD.
